The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as Annexure-A.



The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms must be appointed/ maintained by the institution at all times.






