The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are mentioned below for your information and compliance:

- The institution shall be required to appoint requisite number of faculty as per COA Norms to remove deficiency in cadre-wise faculty and/or create necessary infrastructure, before the commencement of academic session 2024-2025 and submit its compliance to the Council within a period of 3 months.
- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/ maintained by the institution at all times.

The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. **In case the institution is found to be imparting deficient education during 2024-2025, appropriate action shall be initiated against it.**


